In 2014, OSA worked to maintain and enhance parks in North Brooklyn. OSA employed full time maintenance staff who helped to clean and maintain McCarren Park, McGolrick Park, Cooper Park, Sternberg Park, and WNYC Transmitter Park.

OSA contracted a private firm to remove trash from McCarren Park on the weekends and holidays from the start of spring through November of 2014 to help maintain the park during its periods of heaviest use.

OSA Purchased winter equipment, including three 28" snow blowers, shovels, ice picks, and salt spreaders to help clean and maintain the parks of North Brooklyn during the particularly harsh winter months.

OSA purchased and delivered over 13 new mesh trashcans to McCarren, McGolrick, Cooper and Sternberg Parks replacing the oil barrel-style trash cans that had been in the parks previously.

OSA Purchased 8 picnic tables and 8 pop up umbrellas, helped to furnish a dog run, and provided maintenance and supervision for a temporary park at Havemeyer St.

OSA reconstructed a triangle curb at Meeker Street and Morgan Avenue, turning 600 sq. feet of concrete into a garden with native shrubs and safe pedestrian crossing.

OSA managed hundreds of volunteers who donated their time and energy to pick up trash, plant bulbs, and improve neighborhood parks in Greenpoint, Williamsburg, and Bushwick.
